RESOLUTION NO. 3455

A RESOLUTION of the Port Commission of the Port of Seattle, amending Resolution No. 2928; amending the Sea-Tac Industrial Development District, coexistent with Unit 21 of the Port's Comprehensive Scheme of Harbor Improvements, by adding property thereto and enlarging the boundaries thereof; and repealing Resolution No. 2934.

WHEREAS, on March 27, 1984 the Port Commission of the Port of Seattle adopted Resolution No. 2928 and duly created Unit 21 of the Comprehensive Scheme as an aviation related industrial development district known as Sea-Tac Industrial Development District ("STIDD") to function comparably to the marine-related industrial development district known as the Lower Duwamish Industrial Development District; and

WHEREAS, the boundaries of Unit 21 and the STIDD were subsequently amended by Resolution No. 2934, following published notice of a public hearing on the proposed transfer of additional property to the STIDD; and

WHEREAS, the Port currently purchases electric power and energy for the Airport from Puget Sound Energy pursuant to a wholesale power purchase contract subject to the jurisdiction of the Federal Energy Regulatory Commission; and

WHEREAS, the electric power and energy purchased by the Port for the Airport is resold to retail consumers; and

WHEREAS, the Port is negotiating to terminate its wholesale power sales agreement with Puget Sound Energy and to secure a different supplier of electric power and energy for the Port's retail customers; and

WHEREAS, the Port duly published a notice of public hearing on the proposed addition of property to the STIDD boundaries and the contemporaneous modification of Unit 21 of the Port's Comprehensive Scheme, and held a public hearing thereon on April 24, 2001; and

WHEREAS, at said public hearing the Port Commission heard from all persons desiring to speak upon such matters, and considered maps and other data pertaining to the properties proposed to be included in the STIDD and Unit 21 of the Comprehensive Scheme;

NOW, THEREFORE, BE IT RESOLVED by the Port Commission of the Port of Seattle, as follows:

Section 1. Expansion of STIDD and Unit 21 of the Comprehensive Scheme. The properties legally described on Exhibit A, attached hereto and incorporated herein by this reference, are hereby added to the STIDD which is coexistent with Unit 21 of the Port's Comprehensive Scheme, and that Unit is accordingly so amended. The boundaries of the expanded and enlarged STIDD and Unit 21 are shown on Exhibit A.

Section 2. Powers of the STIDD

- (a) General Powers. The STIDD shall enjoy those powers granted to industrial development districts by chapter 53.25, specifically, RCW 53.25.100, as the same shall be amended from time to time.
- (b) Light and Power Facilities. In addition to those powers granted generally, the Port intends that the STIDD shall provide, maintain and operate light and power facilities. All existing electric power and distribution facilities at the Airport shall become part of and be included in the STIDD. The STIDD shall engage in the public business of distributing electric power to any retail consumers within the area serviced by the STIDD requesting service. The area to be serviced by the electric power and distribution facilities shall include those areas described and shown on Exhibit A to this Resolution. Rates for the sale of electric power by the STIDD shall be adopted by the Port Commission and shall be set at a level sufficient to recover the costs of acquiring power for sale to retail consumers and operating and maintaining the STIDD's electrical facilities.

Subject to the authority of the Commission by law and within the Commission's existing bylaws and standing resolution, the responsibility for the operation of the electric facilities of the STIDD shall be vested in the Port's Chief Executive Officer or his/her designee.

Section 3. Repealer. Resolution No. 2934, is hereby repealed in its entirety.

Section 4. Immediate Effect. This Resolution shall take effect immediately upon its adoption.

ADOPTED by the Port Commission of the Port of Seattle at a meeting thereof, held this day of May, 2001, and duly authenticated in open session by the signatures of the commissioners voting in favor thereof and the seal of the commission duly affixed.


