A RESOLUTION

of the Port Commission of the Port of Seattle authoriziang application for, and acceptance of, Phase III funding assistance for an outdoor recreation project to the Interagency Committee for Outdoor Recreation as provided by the Marine Recreation Land Act

WHEREAS, the Port Commission of the Port of Seattle has approved development of the Central Waterfront Project which identifies transient moorage facilities on Elliott Bay in Seattle, and

WHEREAS, under the provisions of the Marine Recreation Land

Act, state and federal funding assistance have been authorized and made

available to aid in financing the cost of land for parks and the

construction of outdoor recreational facilities of local public bodies,

and

WHEREAS, the Port Commission considers it in the public interest to develop a transient moorage on the Central Waterfront in Elliott Bay,

NOW, THEREFORE, BE IT RESOLVED by the Commission of the Port of Seattle as follows

Section 1. That the Port's Executive Director be authorized to make formal application to the Interagency for Outdoor Recreation for furnishing assistance, and to accept funds from said Interagency Committee for the Development of transient moorage in Seattle, Washington

<u>Section 2</u> That any fund assistance so received be used in the development of transient moorage in Seattle, Washington

<u>Section 3.</u> That the Port s share of the project will be derived from the Port s general funds

Section 4. That any facility developed with financial aid through the Interagency Committee for Outdoor Recreation be placed in use as an outdoor recreation facility and be retained in such use in perpetuity unless as otherwise provided and agreed to by the Port_Commission, the Interagency for Outdoor Recreation, and any affected federal agency

<u>Section 5.</u> That this resolution become part of formal application to the Interagency Committee for Outdoor Recreation

Section 6. That adequate notification has been given and an opportunity provided for public input and that published notices have identified affected flood plains and/or wetlands, if applicable

Section 7. That the Port of Seattle does certify that the Port manages the site pursuant to provisions of title 79, RCW, permitting port districts to manage harbor areas located adjacent to port-owned properties following application to the Washington State Department of Natural Resources (DNR) a statutory form management agreement. The Port of Seattle applied for management status in October, 1985. The Port and DNR are currently negotiating final details of a management agreement and expect to execute the final document in 1993. As manager of the site, and based on current knowledge, the Port provides assurance that there are no encumbrances on the land which would restrict recreation use of the area as proposed in this application. The design development plan was approved by the Commission on May 11, 1993. The Port and DNR have jointly obtained grant funding from the Interagency Committee for Outdoor Recreation for the first and second phases of moorage development
