

RESOLUTION NO. 3081

A RESOLUTION of the Port Commission of the Port of Seattle authorizing the Chief Executive Officer to execute an Interlocal Agreement with the City of Seattle to jointly issue a Request for Proposal for an 800 MHZ radio system.

WHEREAS, neighboring public agencies are encouraged to cooperate and assist each other in response to emergencies and disasters, and

WHEREAS, interagency radio communications are essential for deployment of and response by emergency personnel and equipment to protect citizens and to prevent and reduce the loss of life and property, and

WHEREAS, the Port and the City have independently determined to acquire 800 MHZ radio systems, and

WHEREAS, the Port and the City are interested in optimizing radio communications, both during daily and disaster operations, and





WHEREAS, the Port and the City believe the best means of attaining this optimizing is by selection of a common vendor for their respective 800 MHZ radio systems, and

WHEREAS, the Port and the City have determined the best method of assuring a common vendor is through issuance of a joint Request for Proposal (RFP) for this radio system.

NOW THEREFORE, BE IT RESOLVED by the Port Commission of the Port of Seattle that:

1. The Chief Executive Officer of the Port of Seattle is hereby authorized to execute an Interlocal Agreement with the City of Seattle in substantially the form attached hereto as Exhibit "A," and by this reference incorporated herein, for the purpose of issuing a joint RFP to acquire 800 MHZ radio systems.
2. A copy of the final executed Interlocal Agreement shall be attached to this Resolution as Exhibit "B."

ADOPTED by the Port Commission of the Port of Seattle at a meeting thereof, held this 28th day of May, 1991, and duly authenticated in open session by the signatures of the Commissioners voting in favor thereof and the seal of the Commission.

INTERLOCAL AGREEMENT

THIS AGREEMENT entered into on this \_\_\_\_ day of \_\_\_\_\_, 1991, is made by and between THE CITY OF SEATTLE, hereinafter referred to as the "City," and THE PORT OF SEATTLE, hereinafter referred to as the "Port."

In consideration of the covenants herein contained, the parties hereto mutually agree as follows:

ARTICLE I. BACKGROUND

1. Both the City and the Port have independently determined to acquire 800 Megahertz trunked radio systems to replace their existing radio systems. The existing radio systems do not provide the necessary capabilities for over-the-air trunked radio communications between the parties in an emergency, disaster and/or major incident that requires multi-agency response.
2. Two-way radio communications are critical and essential for deployment of and response by emergency personnel and equipment to protect citizens and to prevent and reduce the loss of life and property. The ability of the City and the Port to communicate fully through two-way radio systems, especially in a major emergency or disaster situation, is a high priority and is in the best interest of each party.
3. The marketplace of 800 Megahertz trunked radio systems is such that equipment of one manufacturer is not fully compatible with the equipment of another manufacturer.
4. The parties agree that the goal of full interagency communications, with the optimal efficiency, reliability and functionality, can best be accomplished by the acquisition of systems from the same equipment manufacturer.
5. The parties agree that the best method to assure that their needs are met is through the issuance of a joint Request For Proposal (RFP) for an 800 Megahertz trunked radio system.

ARTICLE II. ADMINISTRATION AND EVALUATION OF RFP

6. The RFP will be administered substantially as set forth in Exhibit A, attached hereto and incorporated herein by this reference.
7. Proposals received in response to the RFP shall be evaluated substantially in accordance with the evaluation criteria set forth in Exhibit A.

ARTICLE III. CONTRACTING

8. Each party shall execute separate contracts for an 800 Megahertz two-way trunked radio system with the apparently successful vendor based on the proposal received in response to the joint RFP.

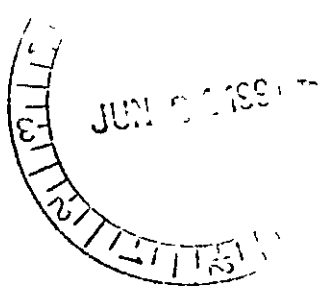


