A RESOLUTION OF the Port Commission of the Port of Seattle amending Section IV.A.3.b. of Salary and Benefit Resolution No. 2563 providing specific details of the mid-year general adjustments to salary rates and ranges of eligible employees; and, whenever such adjustments are implemented, amending Section I.B. and Exhibit A according to provisions established in said Resolution.

BE IT RESOLVED by the Port Commission of the Port of Seattle as follows:

Section 1. The provisions of Section IV.A.3.b. of Resolution No. 2563, adopted December 17, 1974, are hereby amended by the addition of specific provisions for mid-year 1975 adjustments to salary rates and ranges of eligible employees as follows:

Retroactive to June 8, 1975, provide the following adjustments:

- A. All salary ranges shall be increased by 4.46% except those established for New York and Chicago regional positions.
- B. Individual salary rates and ranges shall be adjusted by 2.4% for Chicago employees and by 2.0% for New York employees.
- C. The adjustments for all other individual monthly salary rates shall be as follows:
  - 1. For salary levels of \$774 per month and under, the increase shall be \$35 per month.
  - 2. For salary levels of \$1,693 per month and over, the increase shall be \$75 per month; however, the salary rates for the four nongraded executive positions (General Manager, Deputy General Manager, Assistant General Manager, and Director of Finance and Administration) shall not be adjusted.

- 3. For salary levels between \$775 and \$1,692 per month, the increase shall be 4.46%.
- Section 2. Upon implementation of salary rate or range changes as a result of Section 1. above, the provisions of Section I.B. of Resolution No. 2563 are hereby amended.
- Section 3. Upon implementation of changes provided by Section I. above, the appropriate portions of Exhibit A (Schedule of Authorized Positions) are hereby amended.

ADOPTED by the Port Commission of the Port of Seattle this 22nd day of July, 1975, and duly authenticated in open session by the signatures of the Commissioners voting in its favor and the seal of the Commission.
