A RESOLUTION of the Port Commission of the Port of Seattle canceling certain warrants and authorizing the Port Auditor to henceforth present warrants for cancellation on motion by the Port Commission.

WHEREAS, the Washington State Legislature passed Chapter 131, Laws of 1975, First Extraordinary Session, mandating the cancellation of registered or interest bearing warrants of any municipal corporation not presented within one year of the date of their call, and of other warrants not presented within one year of their issue; and

WHEREAS, the Port Commission is from time to time presented with the necessity of canceling such warrants:

NOW, THEREFORE, BE IT RESOLVED by the Port Commission of the Port of Seattle as follows.

Section 1. Those registered, interest bearing and/or other warrants listed in Exhibit 1 to this Resolution No. 2601, which Exhibit 1 is attached hereto and by this reference incorporated herein, are hereby canceled due to their not having been presented within one year of the date of their call or within one year of their issue.

Section 2. The Port Auditor is hereby authorized to henceforth present to the Port Commission such registered, interest bearing, and/or other warrants for cancellation by motion of the Port Commission on a monthly basis as may be necessary to comply with the provisions of Chapter 131, Laws of 1975, First Extraordinary Session as may be hereafter amended.
