

RESOLUTION NO. 2387

A RESOLUTION of the Port Commission of the Port of Seattle modifying certain rates, rules, and regulations in Seattle Terminals Tariff No. 2-F (F.M.C.-T No. 3), Seattle Container Tariff No. 1 (F.M.C.-T No. 4), Port of Seattle Military Tariff No. 2, and Port of Seattle Foreign-Trade Zone Tariff No. 1-A.

BE IT RESOLVED by the Port Commission of the Port of Seattle, as follows:

SECTION 1. The Port of Seattle does hereby establish and adopt rules, regulations, and charges shown in:

Seattle Terminals Tariff No. 2-F, F.M.C.-T No. 3
Special Supplement No. 3

Seattle Container Tariff No. 1, F.M.C.-T No. 4
Special Supplement No. 3

Port of Seattle Military Tariff No. 2
Special Supplement No. 2


Port of Seattle Foreign-Trade Zone Tariff No. 1-A

copies of which are hereby annexed and made a part of this Resolution, said rules, regulations, and charges to take effect on the dates thereon.

SECTION 2. All rules, regulations, and charges conflicting with the provisions of the above listed pages in said Port of Seattle terminal tariffs are hereby repealed.

SECTION 3. That the Traffic Manager be and has been directed to file said schedules with the Federal Maritime Commission.

TARIFF AMENDMENT DIRECTIVE NO. 52

SECTION 1.
