

RESOLUTION NO. 2203

A RESOLUTION of the Port Commission of the Port of Seattle modifying Unit No. 2, of the Comprehensive Scheme of Harbor Improvements of the Port of Seattle by finding certain described property included therein to be surplus to the Port's needs, pursuant to Chapter 23, Session Laws of the State of Washington, 1965 Session.

WHEREAS, the original Comprehensive Scheme of Harbor Improvements of the Port of Seattle (hereinafter called "Port") was heretofore adopted by Resolution No. 17 of the Port Commission and ratified by the qualified electors of the port district at a special election held therein on March 5, 1912; and

WHEREAS, Unit No. 2 of the original aforesaid Comprehensive Scheme of Harbor Improvements was heretofore amended by the Port Commission of the Port of Seattle by Resolution No. 113 and has been subsequently amended in the manner provided by law; and

WHEREAS, the Port has declared the property described below to be no longer needed for port district purposes; and

WHEREAS, a public hearing was held on September 14, 1965, after notice of such hearing was duly given as provided by law, on the question of whether or not said Unit No. 2 should be further amended and modified to find the property described below to be surplus to the Port's needs; and

WHEREAS, after discussion and consideration of said proposed amendment and modification to Unit No. 2 at said hearing, the Commission has decided that said unit should be amended and modified as hereinafter provided:

NOW, THEREFORE, BE IT RESOLVED by the Port Commission of the Port of Seattle, Washington, as follows:

SECTION 1. That after and pursuant to a public hearing held on September 14, 1965, following notice thereof duly given as required by law, the Port Commission of the Port of Seattle does hereby find the following described property to be surplus to the Port's needs and does hereby amend and modify Unit No. 2 of its Comprehensive Scheme of Harbor Improvements

to find the following described property to be surplus to the Port's needs:

All real property owned by the Port of Seattle in the Plat of Canal Waterway, as recorded in Vol. 21 of Plats, page 71, records of the King County Auditor's office, City of Seattle, State of Washington, except the following described properties:

All of Block 1 of the aforesaid Plat of Canal Waterway.
